Applications are invited from eligible candidates for the posts of PART TIME TEACHERS/ STAFF on purely contractual basis for this Vidyalaya with consolidated pay & service conditions as per KVS, New Delhi, for the academic year 2024-25. The following are the criteria for appointment:

1. The posts are on purely temporary basis for a maximum period of one year or till the regular incumbent joins, whichever is earlier.
2. No TA/DA will be paid for attending the Interview.
3. Applicants are directed to download Application form available at the website of the Vidyalaya and completely fill the form & submit along with self-attested photocopies of certificates at the Vidyalaya office during working days from 09:00 am - 02:00pm till the last date of applying i.e. 29-02-2024 upto 02:00pm.
4. At the time of interview, candidates must bring original certificates for verification purpose only.
5. Candidates applying for more than one post should submit separate Application form along with relevant self-attested photocopied documents.

SERVICE CONDITIONS:

1. The teachers engaged on contractual basis, would have no claim or right for appointment on a regular basis nor will they be a part of the cadre of teachers of KV.
2. The teachers appointed on contractual basis will not be entitled for vacation pay during Summer/Autumn/ Winter breaks. One day's paid leave per month may be sanctioned to all contractual teachers as per the KVS rules in force. Payment shall be calculated on a Pro-Rata basis.

3. Teachers will not be entitled for pay, if they remain absent on a working day, and working hours will be same as regular teachers.
4. Responsibilities include regular classroom activities / copy checking, Invigilation duty/Evaluation work, helping students and colleagues in preparation and in organizing different curricular/co-curricular activities in the Vidyalaya, and all other works assigned by the school administration.
5. Whenever a vacancy arises, candidates will be taken from the final selected panel list.
6. Salary & service conditions will be strictly as per the KVS norms.
